### KOPACHUCK RIDGE ESTATES HOA EMERGENCY POWERS POLICY 9/29/2011

**Purpose:** The purpose of this policy is to ensure that the Committees of the Homeowner Association can achieve a quorum to allow decisions to be made in a timely manner when one or more members are temporarily incapable of participating.

#### **DEFINITIONS:**

An **EMERGENCY** is defined as:

1. Any sudden event or situation that may endanger life, safety, security, health or the well being of Kopachuck Ridge Estates residents or may result in serious damage to KREHA resident property or KREHA property.

#### PROCEDURE:

In the event of an emergency and the AC is unable to obtain a majority vote due to a member that is not reachable, the President of the Association may assume the role of the absent AC member and cast a vote to break the deadlock to reach a decision.

Refer to Appendix A for examples of emergency situations that may require the AC to act quickly and will invoke the provisions of this policy.

In the event that the DRC has been tasked by a HOA member to render a decision quickly to avoid a hardship for one of our members and the DRC is unable to obtain a majority vote due to a member that is not reachable, the President of the Association may assume the role of the absent DRC member and cast a vote to break the deadlock to reach a decision.

Refer to Appendix B for examples of emergency situations that may require the DRC to act quickly and will invoke the provisions of this policy.

All emergency decisions must be documented sufficiently to justify the action taken and any funds expended to mitigate the problem.

In the event that the President is unreachable, the Vice President may act on his or her behalf and render a decision. If both the President and Vice President are unreachable, the AC may draft any board member present or reachable to facilitate a decision.

### APPENDIX A Examples of Emergencies for Assessment Committee Review

(These are examples only.)

- 1. Our private roads are covered in snow and/or ice and not safe for residents and the forecast looks like the roads may not be useable for several days.
- 2. A tree falls across our private road and must be removed immediately to allow traffic to pass.
- 3. A tree on common property has been declared by a certified arborist as a dangerous tree and must be felled immediately.
- 4. One of more of our storm drain system features (catch basin, pond, pipe) is clogged and requires immediate cleaning.

## APPENDIX B Examples of Emergencies for Design Review Committee Review

- 1. A resident has an offer to sell their home contingent on a DRC decision regarding building a structure on the property.
- 2. A resident is having some trees pruned and removed per an approved plan and a dangerous tree is discovered by the tree service. The resident requests approval from the DRC for the tree to be felled while the tree service is on site.
